# Strategy & Planning: Building the Foundation (Source-to-Contract)

Strategic Sourcing: Developing procurement strategies and category management plans based on data.









## E-Tendering & Contract Award: Fair and Transparent (E-Sourcing)

Standardized RFx: Managing all Requests (RFI, RFQ, RFP) within a single digital portal.

Automated Evaluation: Using objective, pre-defined criteria to score bids and ensure fairness and compliance.

Digital Contract Lifecycle: Generating, negotiating, and managing contracts with E-Signature capabilities.









## Execution & Fulfillment: Procuring with Precision (Procure-to-Pay)

Digital Requisition & Approval: Fast, workflow-driven request and approval processes.

Automated PO Generation: Converting requisitions into Purchase Orders (POs) automatically.

Digital Receipt & Inspection: Confirming goods or services delivery electronically, linking fulfillment to the contract.









## Financial Settlement & Payment: Automating the Back Office

E-Invoicing: Receiving and processing invoices electronically from suppliers.

Three-Way Matching: Automated verification of Invoice, Purchase Order, and Goods Receipt to prevent errors and fraud.

Integration with ERP/Treasury: Seamless data flow for final payment release to national financial systems.









## Performance & Value Monitoring: Continuous Improvement

Real-time Spend Analytics: Dashboards for tracking expenditures, savings, and budget consumption.

Supplier Performance Management (SRM): Evaluating supplier reliability, compliance, and contract adherence with scorecards.

Risk Management & Audit Trail: Identifying procurement risks and maintaining a comprehensive, tamper-proof digital record for auditing purposes.
